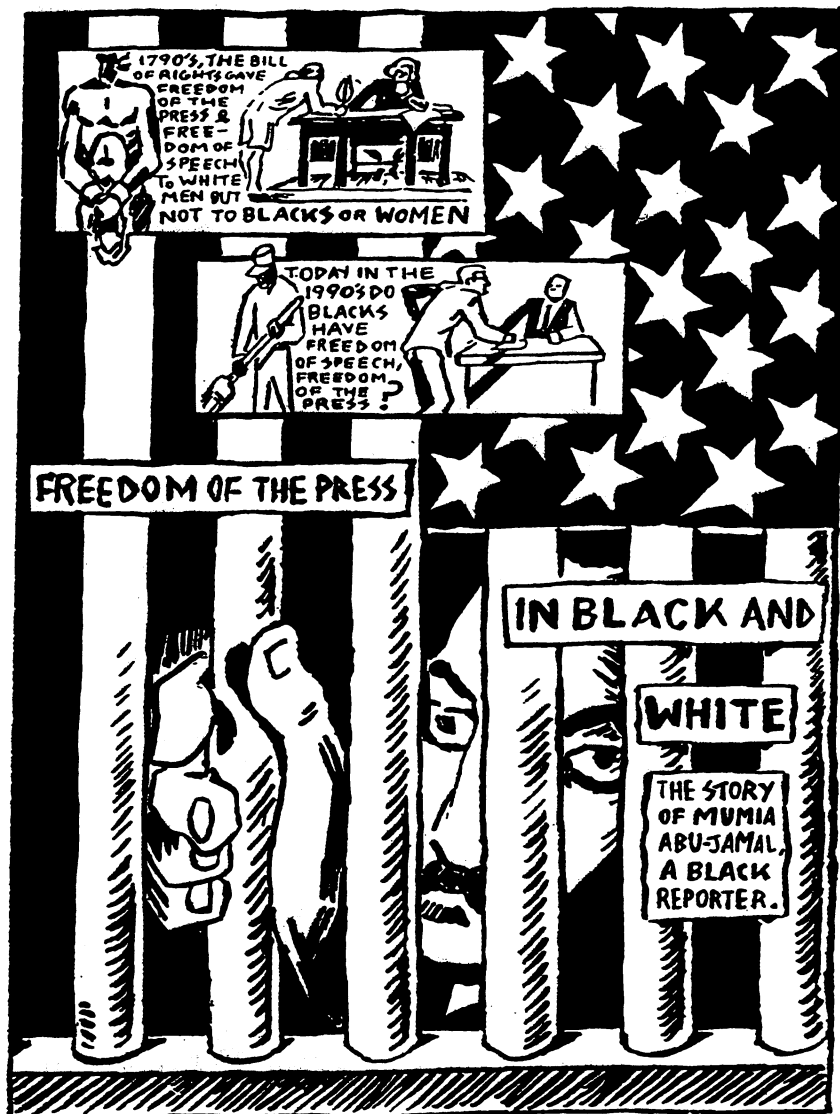

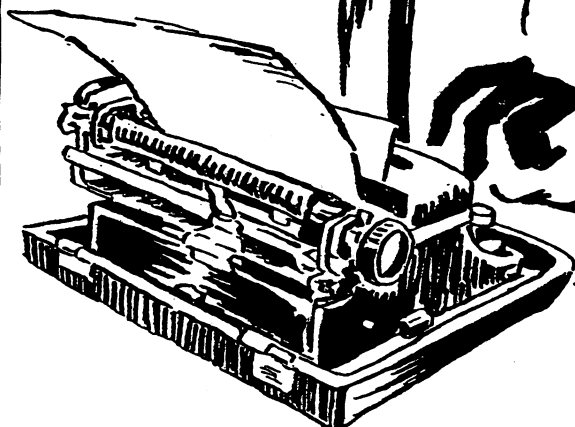




STILL IN HIGH SCHOOL MUMIA BECAME A WRITER FOR THE PANTHERS. HE WAS LIEUTENANT OF INFORMATION OF THE PHILADELPHIA B.P.P. WRITING LEAFLETS + ARTICLES FOR THE BLACK PANTHER PAPER.

IN THE EARLY 1970s the PANTHERS WERE CRUSHED BY THE F.B.I. UNDER THE DIRECTION OF RICHARD NIXON, 38 PANTHERS WERE KILLED.

AND MUMIA, NOW OLDER WITH A FAMILY TO SUPPORT HAD TO MOVE ON IN LIFE.



MUMIA BEGAN A SUCCESSFUL CAREER AS A RADIO JOURNALIST FOR STATIONS LIKE N.R.R. AND NATIONAL BLACK NETWORK.

HE WAS ELECTED PRESIDENT OF THE PHILADELPHIA SOCIETY OF BLACK JOURNALISTS.

WHEN MUMIA FIRST MET MOVE HE DID

FROM PRISON MUMIA WROTE FOR NEWSPAPERS AND MAGAZINES, ABOUT EVERYTHING FROM HIS CASE TO THE DESTRUCTION OF THE BERLIN WALL.

HE REFUSED TO CUT HIS DREADS

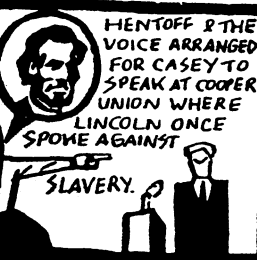

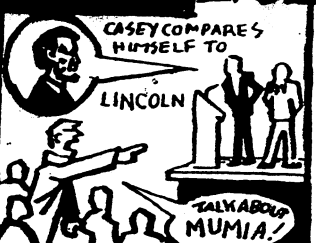

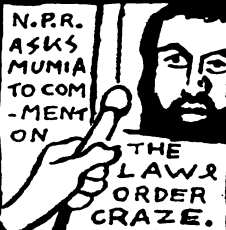
MUMIA REPLIES:

...THE SUBSEQUENT EDITORIALS DENOUNCING THE PROTESTERS FOR THEIR AFFRONT TO THE FIRST AMENDMENT HAVE A DISTINCTLY HOLLOW SOUND, ESPECIALLY TO ONE WHO HAS FOUND THE FIRST AMENDMENT AS APPLIED EQUALLY HOLLOW. FOR ALTHOUGH IT IS UNDOUBTED THAT FEELINGS WERE HURT BY THE PROTEST, NONE OF THE PEOPLE AT COOPER UNION FACE DEATH FOR THEIR WORDS OR PAST AFFILIATIONS, PERHAPS THE ULTIMATE AFFRONT TO THE 1ST AMENDMENT. 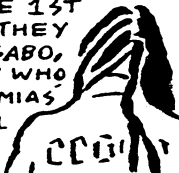

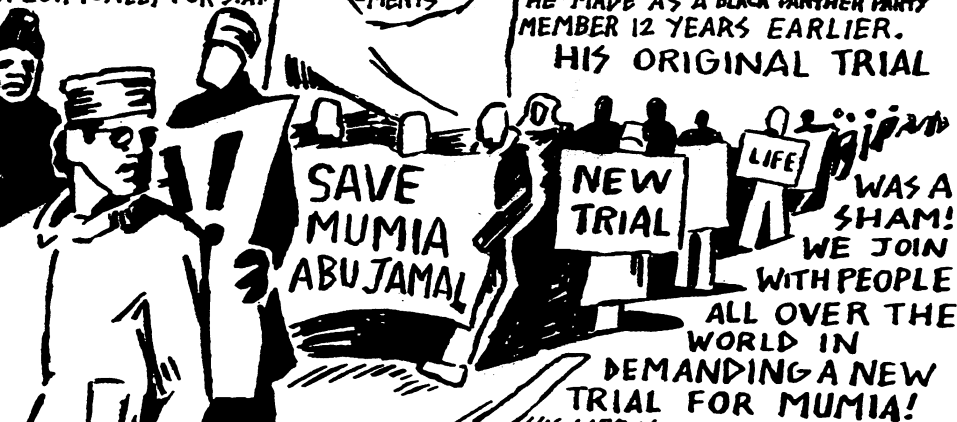

MUMIA ABU JAMAL WAS MINISTER OF INFORMATION OF THE PHILADELPHIA CHAPTER OF THE BLACK PANTHER PARTY. HE BECAME A WELL KNOWN AND RESPECTED JOURNALIST AND HEAD OF THE PHILADELPHIA CHAPTER OF THE ASSOCIATION OF BLACK JOURNALISTS. HE WAS KNOWN AS A SUPPORTER OF THE MOVE ORGANIZATION. 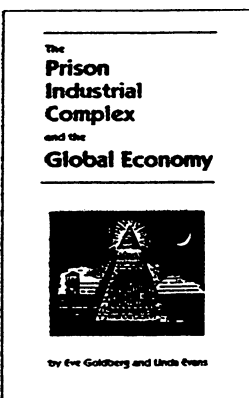
